## **IX. Adjournment**

Individuals who wish to address the Board of Education under Public Comments must sign in with the Board Secretary prior to the start of the meeting. In accordance with Board policy and administrative regulations (BP 1370, 1370-R), individual comments are limited to no more than five (5) minutes and the total time allotted for public comment is not to exceed thirty (30) minutes. In general, the Board will not respond to public comments at the meeting in which they are received, but may refer the comments to the proper school personnel or Board committee to be addressed.

Complaints or concerns regarding Board members or school employees shall be handled through the proper channels at the school building level prior to presentation to the Board of Education. Prior to any such complaint being heard by the Board of Education, said complaint must be delivered in writing to the Board President no less than five (5) school days prior to the meeting, or the Board shall not hear such complaints.

Proposed minutes of this meeting will be available for public inspection at North Muskegon Public Schools, 1600 Mills Avenue, North Muskegon, Michigan 49445 eight (8) business days after the meeting. Approved minutes of this meeting are available within five (5) business days after the meeting at which they are approved at the same address.

Any person who needs special accommodations for participation in a Board meeting should contact the Central Office of North Muskegon Public Schools at 719-4100 at least five (5) days in advance of the meeting to request assistance.
